1. HOW TO ENTER

- a. These rules govern the Mary J. Blige Diamond Booth VIP Lounge Package Contest ("Contest"), which is being conducted by KBLX-FM ("Station"). The Contest begins on Friday, February 14, 2025 at 12:00am (PT), and ends on Sunday, March 2, 2025 at 11:59pm (PT) ("Contest Dates"). KBLX-FM may elect at its sole discretion, to continue the contest beyond this date if it so chooses. Entrants may enter online only.
- b. To enter the Contest, entrant may enter online beginning Sunday, March 2, 2025 at 12:00am (PT), and Sunday, March 2, 2025 at 11:59pm (PT) ("Entry Period").
 - i. To enter online, visit www.KBLX.com and follow the links and instructions to enter the Contest and complete and submit the online entry form ("Mary J. Blige Diamond Booth VIP Lounge Package Contest Entry") during the Entry Period outlined above. Entries are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Only one (1) "Mary J. Blige Diamond Booth VIP Lounge Package Contest" Contest entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of

an entry shall not be deemed proof of receipt by the Contest Administrator.

- ii. Only one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

- i. To enter on-air, listen to the Station between Tuesday, February 18, 2025, at 6:55am (PT) and Friday, February 21, 2025, at 8:15am (PT) and between Thursday, February 27, 2025, at 9:00am (PT) and ending on Thursday, February 27, 2025, at 5:15pm (PT), listen for the cue to call to be announced by the on-air host. The designated caller into the studio at 415-888-1029 will win a qualifying prize of two (2) tickets to Mary J. Blige: The For My Fans Tour with Ne-Yo and Mario on Friday, March 7, 2025 at Chase Center in San Francisco, CA. Tickets are valid for Friday, March 7, 2025 ONLY. Entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.
- c. Due to delays in the online streaming of the Station’s broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. There will be up to thirteen (13) on-air qualifying prize winners and one (1) grand prize winner chosen from the on-air and online entries received at www.KBLX.com at the conclusion of the Promotion.

- e. Only one (1) entry per person is permitted. There will be a total of one (1) prize winners selected in the Online Contest.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in one of nine (9) county jurisdiction that makes up the Greater San Francisco / Bay Area listening area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

Blige: The For My Fans Tour with Ne-Yo and Mario on Friday, March 7, 2025 at Chase Center in San Francisco, CA. Tickets are valid for Friday, March 7, 2025 ONLY. Verified winners only and available within thirty (30) days of Station's receipt form of all required completed and signed documents prizes and another winner(s) will be selected. The Approximate Retail Value ("ARV") of the prize(s) is \$76.00.
 - c. Prize does not include any travel to the event.
 - d. Prize will be mailed, unless otherwise determined by the Station. Winner will be required to provide his/her social security number and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting the Prize.
 - e. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets that have been awarded in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.
 - f. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.

- b. Up to Thirteen (13) on-air qualifying prize winners and One (1) grand prize winner will be selected at the conclusion of the promotion on or around Monday, March 3, 2025 at around 12:00pm, from the online entries received at www.KBLX.com as described above in Section 1 of these Official Rules.
- c. Odds of winning a qualifying prize depend upon the number and order of eligible entries received.
- d. Winners must listen to the Station to win but do not need to be present to win. All prizes will be sent by mail. “Authorized Account Holder” is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant’s disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.

- b.
